Terms & Conditions:	<ol style="list-style-type: none"> 1. “Wynn Signature - 2025 Hypercar Exhibition – Ultimate Speed Challenge” (the “Promotion”) is organized by Wynn Resorts (Macau) S.A. (WRMSA) (“Wynn”), a company incorporated under the laws of Macau with its registered office at Estrada do Istmo, Cotai, Macau, along with all other entities directly or indirectly controlled by Wynn Resorts Limited (a corporation registered in Nevada, USA, and the parent company of WRMSA). 2. This promotion will be held from 29 September 2025 (10:00 AM) to 16 November 2025 (00:00 AM) at Wynn Palace (hereinafter referred to as the “Promotion Period”). 3. The promotion is exclusive to 21 years old or above, and must be an existing or on-day newly signed-up Wynn Rewards member or Wynn Insider member in order to participate in this Promotion. Each member will be eligible to register one (1) participation per day. 4. Participation in this simulator equipment is restricted to individuals who are 152cm or above. 6. Registration and participation process are as follows: <ol style="list-style-type: none"> 6.1 Present Wynn Rewards membership or Wynn Insider membership 6.2 Provide Participant’s name and contact number. 6.3 After registration is completed, staff will guide Participant to the simulator game zone 6.4 Participant will have a maximum of 10-minute for the experience. Participant may complete a maximum of 3-lap race and the fastest lap completion time will be recorded. 6.5 The result will be calculated every hour, and the system will automatically determine the top three (3) fastest completion times within each hour. 6.6 The top three (3) times will be displayed on the electronic screen at the simulator zone. 6.7 Participant with the fastest completion time each hour (the “Winner”) will receive a personalized Cap designed by street artist Saiff Vasarhelyi (the “Prize”) 6.8 In the event of a tie for the fastest completion time, all tied Participants will be eligible to receive the Prize.

7. Winners will be notified via SMS and phone after the announcement.
8. Prizes must be claimed at the designated location at Wynn Palace, and all unclaimed prizes will be forfeited after November 23, 2025. Winners must present their registered Wynn member ID, name and contact number and the winning SMS message to claim their prizes as follows:

By participating in this Promotion, Participants authorize Wynn to collect, use, store and process, automatically or mechanically, the abovementioned Participants personal information (hereinafter the "Data"), for the said purposes and for audit purposes (including audits by Wynn Group companies internal and external auditors). Furthermore, the Participants consent to the communication and transfer of such Data to other companies directly or indirectly controlled by the ultimate parent company of

Wynn Resorts (Macau) S.A., Wynn Resorts, Limited (with all said companies directly or indirectly controlled by Wynn Resorts, Limited, including Wynn Resorts (Macau) S.A., herein collectively designated as the “Wynn Group”) and transferred to any jurisdictions, or on the cloud, including, without limitation, the United States of America. The Participants further consent to the communication and transfer of this Data, in confidentiality, to such service providers as may be currently used or selected by any of Wynn Group companies in the future to assist with the administration and management of data, or any marketing campaigns, and which are legally or contractually required to comply with the Macau law on data protection. Participants have the right to access their Data, request additional information, require any necessary amendments, or refuse or withdraw the consent given herein, by sending an email to dataprotection@wynnmacau.com. The refusal or withdrawal of consent will prevent participation in the Promotion.

18. The Participant authorizes that, subject to WRMSA’s privacy policy (available as indicated below), the Data be: (i) disclosed to designated service providers or “Contractors” (including, without limitation, and as applicable, Wynn external auditors, legal and financial advisors, service providers that own or operate the social media platform this Promotion is accessible from, and other service providers that own, operate or assist with systems or platforms the services provided by Wynn are based in, and data management service providers), and to public authorities with jurisdiction over Wynn, and (ii) transferred to, processed or stored in any jurisdictions, or on the cloud, including, without limitation, the United States of America and Macau. The Participant hereby gives his/her separate consent to the third-party service providers (if any) processing his/her personal data according to the provisions of these Terms and Conditions.

19. The Participant hereby agrees that while participating in the Promotion the Participant shall not:

- (a) violate any laws, regulations, international treaties or conventions, policies and terms (including policies set by the owner and/or operator of the Wynn insider Program this Promotion is accessible from) nor shall the Participant violate public interest (such as post or otherwise make available any data or materials that violate the constitutional or legal principles of any relevant jurisdiction or otherwise harm the image of the relevant sovereign state);
- (b) impersonates a different person;
